Historically, housing programs are disproportionately affected when budgets are singled out for congressional review. Regardless of which party is in power, budget challenges remain a constant for housing professionals.

## **Election Season Is Opportunity Season**

The election primaries held Aug. 14 resolved many questions as to which individuals will be headed to Tallahassee as state legislators. Of course the upcoming November elections will complete the final picture, particularly between some very high profile Democrat versus Republican races.

Of the 120-member House, 44 seats have been decided, of which 33 are returning incumbents. Another 22 face only writein candidates in November, leaving almost

half of the House of Representatives still "up for grabs."

Similarly, of the 40-member Senate, eight state senators have already been decided, and in November, 28 more seats will be filled.

We have a tremendous opportunity to meet these folks now as they are scouring their geographic districts looking for voters. By inviting



## **Two Types of Happiness**

Tis nothing good or bad/But thinking makes it so — William Shakespeare

If you are struggling with making a decision that is weighing heavily on your future happiness, I invite you to listen to Daniel Gilbert at www.Ted.com/talks. Gilbert, a psychologist and a happiness expert at Harvard University, is the author of *Stumbling on Happiness*. I always considered it a luxury to have the freedom of choice, but Gilbert explains how it can work against us.

He argues that one of the key features of mankind (aside from opposable thumbs and standing upright) is our ability to use our prefrontal cortex to mentally picture the probable results of our decisions before we even take action. This mental capacity enables us to choose and guide our behavior toward more desirable outcomes, but it can also have a surprising, inverse effect on our ability to find happiness in today's society.

Apparently scientists have found that there are actually two different, but real, types of happiness (synthetic vs. natural) that work to minimize the impact of our decisions on our level of happiness. The freedom to make our own decisions leads to

natural happiness—a sense of pleasure in getting what we want. Synthetic happiness works to make us happy with what we end up with. Having too many choices—something we usually consider being positive—can actually make us unhappy because it results in second-guessing what we really want.



## Step Up For Students Offers K-12 Scholarships for Low-Income Florida Schoolchildren

Step Up For Students is a nonprofit organization that administers the Florida Tax Credit Scholarship for low-income students (K-12). Many families still don't know the option exists, but Florida has the nation's largest scholarship program giving low-income families the ability to choose the school that best meets their children's needs. Families who qualify for the free or reduced price lunch program may also qualify for the Step Up For Students Scholarship. Scholarships are based on income, not academic performance. Scholarships are first-come, first-served. Once a student's eligibility is verified, the parent has the freedom to choose any one of more than 1,350 participating private schools across the state, or they can use a \$500 transportation scholarship to offset travel costs to an out-of-district public school. The scholarship also has special eligibility standards for foster and homeless children. Please check www.StepUpForStudents.org for additional eligibility requirements, application deadlines and to apply.

218,000 SCHOLARSHIPS HAVE ALREADY BEEN AWARDED TO LOW-INCOME FLORIDA SCHOOLCHILDREN.

The Florida Legislature created the Tax Credit Scholarship in 2001 to allow families to consider school options they may not have been able to afford. Step Up For Students, the nonprofit that administers this program, awards scholarships based on income, not academic performance.

Families who qualify for the free or reduced-price lunch program may qualify for the scholarship program too. Students who qualify may receive up to \$4,335 for private school tuition and fees OR \$500 to help cover transportation to a public school in another county.

During the 2011-12 school year, about 39,000 Florida children benefitted from this scholarship and were able to choose from one of approximately 1,350 private schools throughout the state. It's your child, it's your choice.

Our goal is to give your family a choice in your child's education. These scholarships are awarded on a first-come, first-served basis so don't wait until it's too late.



these candidates to visit our respective agencies, we have the perfect opportunity to explain the difference between affordable housing and public housing, as well as what our mission is and how PHAs are an entity of both the state and federal governments at the same time.

During the upcoming 2013 legislative session, not just rehab funding, but property taxes will likely take center stage for FAHRO. Not all, but various county property appraisers have begun a more detailed scrutiny of how PHAs operate, their relationship to tax credit projects, commercial enterprises on PHA land and in particular, any and all types of operations outside of the historic role of public housing authorities.

Meeting candidates now who are running for office is our best way of ensuring our protection and success in the future. Almost every county in Florida has at least one, if not more than one, contested House or Senate race going on.

In most cases, our own PHA board members are probably very well versed as to who these folks are and have a good idea of the likely winners. Use your board member relationships to arrange introductions or invitations to candidates to visit your PHA. Establishing and fortifying a working relationship with your legislator not only helps FAHRO in Tallahassee, but can also become invaluable to your particular agency in any number of ways at the local level.

And of course, if you need help in identifying or contacting any legislator or candidate, we are happy to respond immediately.


